SARAA Speaker fees and consultation fees for outside organisations

Speaker fee tiers:

1. Are you a Business or Government Department?
 - a. Yes - you pay the “business/commercial” fee
 - b. No - following questions
 - i. Will participants be charged to attend or pay a membership/joining fee?
 - ii. Is the event/activity/meeting in favour of a particular cause such as political rallies and or religious/spiritual gatherings?
 - iii. Is the event/activity for a closed group/club/organisation or family gathering?
 1. Yes - you pay the “private” fee
 2. No - following questions
 - iv. Will the event/activity be open, inclusive and nonpartisan for all members of the public to attend?
 1. Yes - you pay the “community” fee

2023 Speaker fees (inclusive of preparation time):

- Business:
 - Minimum for in person \$350, \$250 for online, for up to an hour (\$250 per subsequent hour in person, \$175 per subsequent hour online) +GST
- Private:
 - Minimum for in person \$250, \$150 for online, for up to an hour (\$200 per subsequent hour in person, \$100 per subsequent hour online) +GST
- Community:
 - Minimum for in person \$100, \$70 for online, for up to an hour +GST

Keynote conference session

- Business:
 - Minimum for in person \$2000, \$1500 for online
- Private:
 - Minimum for in person \$1500, \$1000 for online

- Community:
 - Minimum for in person \$750, \$500 for online

Note that special circumstances can apply to some community organisations where we will not charge a fee, these will be assessed on a case by case basis.

For in person events where travel is required, there may be additional charges for travel and accommodation if necessary.

Consultation fee tiers (definitions borrowed from Australian progress):

- Small non-profit (for non-profits with an annual revenue of less than \$500k)
- Regular non-profit (for non-profits with an annual revenue between \$500k - \$3 million)
- Large non-profit (for non-profits with an annual revenue of more than \$3 million)
- For-profit or government

Consultation fees:

- Small non-profit
 - Minimum of \$200 per hour +GST
- Regular non-profit:
 - Minimum of \$250 per hour
- Large non-profit
 - Minimum of \$350 per hour +GST
- For-profit or government
 - Minimum of \$500 per hour +GST
